THE SCOPE OF THIS BID CATEGORY SHALL INCLUDE, BUT NOT BE LIMITED TO THE FOLLOWING ITEMS:

- 1. Provide all Shop Drawings, Submittals & Samples as indicated, specified & required.
- Provide all lay out required for the work of this contract & coordination with all other trades for the work of this category.
- 3. Provide all barricades, traffic control & safety devices as required to maintain public and job site safety throughout the duration of this work, as required for the work of this category.
- 4. Remove all concrete wash outs & debris from the site, that are generated by the work of this category.
- 5. Provide all saw cutting as required for the work of this category.
- 6. Protection of all surrounding & adjacent surfaces and/or items that are existing to remain and restoration of any existing and adjacent areas that are disturbed and/or damaged by the work of this category. Areas disturbed shall be restored to their original condition by this category.
- 7. It is the responsibility of this Bid Category to review <u>all</u> drawings and drawing notes, including architectural, mechanical and electrical drawings, and include items requiring work that is generally defined as the responsibility of this Bid Category within the work description unless otherwise noted above in the scope of work.
- 8. This contactor will be responsible for all re-mobilization costs for all phases of work.
- 9. This contractor is to provide all legal disposal off-site of the debris that is a result of their work.
- 10. Coordination with other trades, including mandatory participation in job meetings.
- 11. Coordinate the location and sizes of all openings with the appropriate trades.

- 12. Perform all selective demolition work as indicated, specified & required.
- 13. Furnish, install and maintain all shoring and bracing as required. Leave shoring in place until new building systems are in place and then remove as required. Prior to installation of shoring and bracing efforts, provide shop drawings on the proposed shoring and bracing design. A registered engineer in the State of Michigan must seal drawings.
- 14. Perform all trimming and adjusting of work for installation of new construction. Coordinate limits of wall demolition with architectural drawings and all critical trade contractors.
- 15. A) Perform excavation for all strip/spread foundations as required after major earthwork cut to top of footing elevation is complete for the gym and classroom areas.
  - B) Perform all required excavation complete for foundation and piers at south side of building along new corridors and main entry, outlined by column lines 2.1 thru 11 and A thru G.
  - C) Install all exterior door entry supported slab foundations, inclusive of all excavation required.
- 16. Provide all lay out required for the work of this contract & coordination with all other trades for the work of this category. Owner will provide major control point lay-out.
- 17. Coordinate with Architect/Engineer before penetrating any structural members.
- 18. The contractor's field superintendent shall be present during testing, inspections and field reviews conducted by the various inspection agencies.
- 19. This contractor shall furnish, upon completion of work, asbuilt mylar drawings showing the actual installation of the work as completed.
- 20. A) Furnish and install all concrete foundation systems as indicated, specified and required; inclusive of strip/spread footings, walls, entry stoop footings, elevator pit and sump, formwork, reinforcing steel, set all anchor bolts and grout leveling plates, etc. to produce a complete foundation system.

- B) Furnish and install dumpster enclosure foundations complete as indicated, specified and required.
- 21. Furnish and install waterproofing system complete for elevator pit as indicated, specified and required; inclusive of wall prep, primer, membrane and protection board.
- 22. Provide all rough and finish carpentry work complete as indicated, specified and required; inclusive of all required materials, fasteners and anchors.
- 23. Provide all cabinetry, millwork, solid surfacing and manufactured casework complete as indicated, specified and required; inclusive of all fixed cabinetry, work surfaces, classroom cabinetry, display cases, window sills, etc.
- 24. Provide all EIFS and DEFS work complete as indicated, specified and required; inclusive of all required, jointing, caulking and sealing.
- 25. Provide all light gage metal framing complete as indicated, specified and required; inclusive of all sheathing, etc. ready for finishing or subsequent trades.
- 26. Provide all joint sealant and caulking work complete as indicated, specified and required.
- 27. Provide all metal stud and gypsum wall board work complete as indicated, specified and required; inclusive of all insulation within metal stud partitions.
- 28. Provide all hard tile work complete as indicated, specified and required.
- 29. Provide all acoustical ceiling work complete as indicated, specified and required.
- 30. Provide gymnasium wood floor system complete as indicated, specified and required; inclusive of all court striping, graphics and logo work indicated.
- 31. Provide all painting, epoxy, staining and finishing work complete as indicated, specified and required; inclusive of wall graphics in gymnasium.
- 32. Provide all toilet partitions and toilet accessories complete as indicated, specified and required; inclusive of janitor closet equipment, mop racks, framed mirrors, electric hand dryers, grab bars and sanitary napkin disposals.

- 33. Provide all metal lockers and benches complete as indicated, specified and required.
- 34. Provide all fire extinguishers and cabinets complete as indicated, specified and required.
- 35. Provide all wire mesh partitions complete as indicated, specified and required.
- 36. Provide all safe hooks complete as indicated, specified and required.
- 37. Provide all signage complete as indicated, specified and required; inclusive of all door and room identification signage and illuminate building lets above main entry.
- 38. Provide power operated bleacher system complete as indicated, specified and required.
- 39. Provide all gymnasium furnishings and equipment complete as indicated, specified and required; inclusive of basketball backstops, volleyball nets, poles and floor inserts, wall pads, tectum sound panels and projections screen.
- 40. Provide all gymnasium scoreboard systems complete as indicated, specified and required. Electric power and wiring by category 1600
- 41. Provide all visual display boards complete as indicated, specified and required; inclusive of all markerboards and tackboards.
- 42. Provide all doors, frames and hardware complete as indicated, specified and required; inclusive of hollow metal frames and doors, wood doors and finish hardware, final cores and keying by Owner.
- 43. Provide all window treatments; inclusive of all shades, blinds etc.
- 44. Provide daily clean-up of all areas affected by the work of this category; inclusive of removal of all tags, stickers, labels etc. from all materials, devices and equipment supplied by this category and removal of all trash and debris from the building s and deposited in dumpsters.
- 45. Removal and vacuuming of all dust generated by sanding/finishing of drywall systems.

- 46. Provide all building, thermal, sound and firestop insulation complete as indicated, specified and required; inclusive of all fiberglass batt insulation, rigid insulation adhered to substrates other than masonry and firestop insulation.
- 47. Setting of steel guard posts as indicated, specified and required; inclusive of excavation, concrete footing and fill. Guard posts supplied by category 0500.
- 48. Provide all miscellaneous specialties as follows: Dedication plaque, gym projection screen, recessed display cases, backlit exterior letters (Alternate NO. 7), storage mesh partitions, airphone unit and handsets, vertical plastic corner guards and "safe hook" coat rack system.
- 49. Obtain general building permit from local authorities; Owner will reimburse cost of all permits.
- 50. Daily clean-up and removal of debris generated by the work of this category and placed in dumpsters. All bulky items and boxes shall be broken down prior to placement in dumpsters. Debris will not be allowed to accommodate on the site or inside the buildings.
- 51. Provide all architectural louvers complete as indicate, specified, and required.
- 52. Provide rolling counter door complete as indicated, specified and required.
- 53. Quotation of Alternate No. 1,2,3 and 7.
- 54. Quotation of Unit Prices No. 1,2,3 and 4.
